The appointee shall report to the Chief Education Officer, Doda within a period of 21 days from the date of issuance of this order and she shall be allowed to join only after production of the following certificates/documents in original:-

- 2. Permanent Resident Certificate.
- 3. Character antecedent's certificate.
- 4.No Demand certificate from DIC & Employment Exchange
- 5. Category Certificate, if any

However, if on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of her character and antecedents is received from Inspector General of police, CID, to whom a reference shall be made by the Chief Education Officer, Doda.
