Subject : Establishment of State Council of Educational Research and Training (SCERT) Jammu & Kashmir.

Sanction is accorded to:-

- i) Establishment of State Council of Educational Research and Training (SCERT) in J&K (as a Society under Societies Registration Act,) by merging existing two State Institute of Education (SIE) at Jammu and Kashmir with following organizational setup:-
 - a) J&K SCERT, Central Move Office.
 - b) Divisional Offices of SCERT at Jammu and Srinagar with distribution of Academic Branches as in Annexure-A.
 - c) Existing 20 District Institute of Education & Trainings (DIETs) shall function under direct administrative control of respective SCERT wings, which shall function under administrative control of Director, JK SCERT, who shall function under over all supervision of the Administrative Department of School Education to provide academic & resource support at grass-root level.
- ii) Staffing requirement of 239 posts shall be met by rationalization/ corresponding reduction from existing sanctioned posts in SIEs (105), DIETs (110) & School Education Department (24) of academic & non academic categories which includes subsuming 105 posts (existing sanctioned strength of State Institute of Education Jammu and Kashmir) for SCERT J&K with Central Move office of Director & two Regional Offices at Jammu and Srinagar as per details at Annexure-B. This will be an interim arrangement. Thereafter all the posts shall be filled up as per Service/Financial regulations of SCERT, J&K and the UGC norms.
- iii) A post of Director JK SCERT, is created in the Pay Scale of Rs.144200-218200 (Level-14) by upgrading one post of Joint Director in the Pay Scale of Rs.78800-209200 (Level-12) in School Education Department.

- iv) Minister Incharge School Education will be the Member of the Governing Council.
- v) Till appointment of a fulltime Director, the charge of the Director SCERT shall be assigned to Chairman, BOSE, as an interim measure.


