Subject: - Assigning of look after charge of Headmasters and equivalent to Masters.

Government Order No: 205/-Edu of 2022 Dated: 08.08.2022

Pending clearance from Departmental Promotion Committee and in continuation to Government Order No. 1746 -Edu of 2022 Dated: 27-06-2022, sanction is hereby accorded to the assigning of look after charge of Headmasters and equivalent to Masters (Dropees) as in Annexure-A to this order for a period of six months or till post is filled up on regular basis by the Departmental Promotion Committee (DPC) / JKPSC.

It is further ordered that:

a. The above arrangement shall be purely temporary, in the interest of administration and administrative exigency and shall not confer any preferential right/claim on the officials for seeking regularization /confirmation as Headmaster and equivalent, which shall be made strictly in accordance with the applicable rules.

b. The above arrangement shall be without prejudice to the outcome of writ petition(s), if any pending consideration before any competent court(s) of

law.

Further the above arrangements are subject to the following conditions:

i. The look after Headmaster shall join the new place of posting within 07 days, failing which it shall be construed that he/she has forgone his/her new assignment as look after Headmaster and equivalent and action under rules shall follow.

ii. The Chief Education Officers concerned shall verify degrees of the above Masters to satisfy themselves about the validity/genuineness of the academic credentials of the officials as per UGC/AICTE/DEC guidelines and shall report immediately if degree of any official is found fraud/fake and the new assignment shall be withdrawn ab-initio.

iii. The officials shall be considered in DPC/JKPSC strictly as per eligibility/seniority/accrual of vacancy and after obtaining CID

clearance/Vigilance clearance from GAD/ACB.

The look after Headmasters shall be vested with DDO powers in addition to Administrative Powers.
