- 2. Permanent Residence Certificate (PRC)
- 3. Academic Qualification Certificate
- 4. Technical Qualification Certificate
- 5. Character/antecedents verified from CID (J&K Police) required.
- 6. No Objection certificate from DIC/Employment Exchange.
- 7. That the appointee has not been selected by any Recruiting Agency/or appointed in any other Government Department.

- 8. That the allowance other than what was admissible/due has not been drawn.
- 9. That the employee is working against clear vacancy/post and has not been conveyed/recommended earlier by the Empowered Committee.

The order of regularization shall be subject to the cancellation ab-initio, in case, at any stage it emerges that the certificates/documents furnished by the appointee are fake/ficticious.
