Sanction is hereby accorded to the release of 1st instalment as recurring Central Assistance to the tune of **Rs 2039.00 lac (Rupees Twenty Crore Thirty Nine lac Only)** under CSS of Teacher Education for the year 2017-18, in favour of Financial Advisor/CAO, School Education department and Director School Education Kashmir/Jammu for further placement at disposal of concerned Principals and as per details at **Annexure-A**, and its utilization during 2017-18. The category wise funds shall be restricted to **General category (Rs 1839.00 lac) SCSP category (Rs 200.00 lac).**

The release of funds is subject to the fulfilment of following conditions:-

- I. The funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GoI's prescribed guidelines.
- II. Central Assistance be utilized in conformity with the prescribed guidelines of the scheme issued by the Government from time to time.
- III. Physical and financial report should reach this department well before 5th of every month.
- IV. Utilization certificate of the funds shall be submitted soon after the closure of financial year with copy to the Finance department.
- V. CAOs of Directorates of School Education shall vouchsafe the utilization of funds as per codal procedures/ GoI guidelines.
- VI. The funds shall be utilized only for the purpose for which these have been sanctioned and the unspent balance if any shall be conveyed to the administrative department on or before 31.3.2018.
- VII. The expenditure shall be incurred as per following classification for proper accounting.
