Whereas, the petitioner approached the Hon'ble High Court through the above titled writ petition, praying therein for her transfer from District Kathua to District Jammu on account of her marriage;

Whereas, the Hon'ble High Court disposed of the writ petition vide judgment dated 27.08.2015, the operative portion of which is reproduced as under:-

"Viewed, thus, this petition is disposed of with a direction to the petitioner to make a representation to the competent authority and direction to the competent authority to accord consideration thereto in accordance with Rules. In order to enable petitioner to make representation, petitioner be not relieved from her present assignment for two weeks hereafter".

Whereas, her appointment as Teacher has been made in District Cadre of Kathua district based on her PRC issued by Deputy Commissioner, Kathua dated: 18.12.1996;

Whereas, the Permanent Resident Certificate (PRC) of petitioner's husband is of Kathua, issued by Deputy Commissioner, Kathua on 14.7.1994;

Whereas, her claim for inter-district transfer has been examined as per the Transfer Policy of School Education Department issued vide Government Order No: 622-Edu of 2015 dated: 22-12-2015, relevant para of which is quoted below:-

"In case of marriage, inter-cadre transfer of lady official shall be allowed provided they have served five year in their parent cadre (district/divisional) cadre. However, this would be subject to availability of vacancies and department's requirements". Whereas, the department has also issued a circular vide No:Edu/Gen/82/2015 dated 23.10.2015 to streamline the processing of such cases;

Whereas, the inter-district transfer are being effected considering the PRC of the husband which, in the instant case, is of Kathua district;

Therefore, in light of the policy of the government, the request doesn't qualify for inter-district transfer and hence rejected.
