2. **Whereas**, Director, School Education, Jammu was requested to serve the necessary Article of Charges alongwith Statement of Imputations to the delinquent officials for obtaining their replies in written alongwith documentary evidences, if any, and DSE Jammu vide letter No. DSEJ/Gaz/36049-50 dated 18.07.2018 appointed Mr. Nath Ram, the then I/C Principal, DIET Banihal, Ramban (now I/C Field Advisor) as Inquiry Officer; and
3. **Whereas**, Director, School Education, Jammu vide letter No. DSEJ/Gaz/45656 dated 10.09.2018 forwarded replies of the Article of Charges submitted by delinquent officials alongwith enquiry report of Principal, DIET Banihal, Ramban (Inquiry Officer);

4. Whereas, enquiry report submitted by the Inquiry Officer was examined in the department and it was decided to place the case before the Review Committee constituted for the purpose; and

5. Whereas, the case was deliberated by the Review Committee held under the Chairmanship of Principal Secretary to the Government, School Education Department on 10.08.2020 at 03:00 PM, in Civil Secretariat, J&K, Srinagar, and after thorough deliberations it has been decided to re-instate officials in question with a penalty of withholding two increments alongwith fine of Rs. 10,000/- in each case and their re-instatement subjected to outcome of any criminal case pending in any Court of Law. Besides, it has been decided that these officials be given non-sensitive posting in future.

6. Now, therefore, in light of the above recommendations sanction is accorded to re-instatement of following officials with a penalty of withholding of two increments alongwith fine of Rs. 10,000/- in each case. Besides, re-instatement shall be subject to outcome of writ petition(s), pending if any, before any competent Court(s) of law;




