## **Terms of Reference:-**

- i. Open Single Nodal Account as per procedure mentioned in Department of Expenditure O.M. No.1(13)/PFMS/FCD/2020 dated: 23-03-2021 and 08-12-2021.
- ii. SNA will be registered in the Public Financial Management System (PFMS).
- iii. There will be clear bifurcation of the Central and UT share funds in the SNA account.
- iv. Zero balance bank accounts of the Implementing Agencies (IAs) down the ladder will be opened.
- v. All the IAs will be registered in PFMS and their zero balance bank accounts will be mapped in PFMS.
- vi. Separate budget lines for Central and State shares will be opened by every State Government/ Union Territorty in the State/UT budget for centrally sponsored scheme having UT and necessary priovision of funds will be made in the UT budget for all the components.
- vii. State Government Integrated Financial and Management Information System (GIFMIS) is enabled to capture scheme component-wise expenditure along with FFMS scheme codes and unique code of the agencies incurring the expenditure.
