As recommended by the Jammu & Kashmir Public Service Commission, in accordance with Jammu and Kashmir Special Recruitment Rules 2015 issued vide SRO-202 of 2015 dated 30.06.2015, sanction is accorded to the appointment on regular temporary basis of Ms Isha Gupta D/o Shakti Bushan Gupta R/o House No.25, Sec-2, near post office, Channi Himmat, Jammu as Lecturer (Statistics) in the School Education Department, in the pay scale of Rs.9300-34800+Grade Pay of Rs.5400, strictly in terms of Rule 9 of SRO-202 of 2015, dated 30.06.2015.

The appointee shall report to the Directorate of School Education, Jammu who will allow her to join only after verification of the following documents in original:-

- a. Permanent Residence Certificate.
- b. Age and Health Certificate.
- c. Academic Qualification and Category Certificate (if any) and genuineness thereof.
- d. No Loan Certificate from DIC/ concerned District Employment Office.
- e. Character/ antecedents certificate.

If on verification, the certificates produced by the appointee proved to be fake or forged, the appointment shall stand cancelled ab-initio.

The appointment of above candidate shall further be subject to the following conditions:-

a. That the appointee shall be initially on probation for a period of five years and after completion of five (5) years of her service, she shall be declared as permanent subject to passing of such tests, or successfully undergoing such training, as provided under Rule-8 of SRO-202 of 2015 dated 30.06.2015;



- b. The appointee shall have to necessarily work for a period of five (5) years on the post against which she has been appointed and appointee shall not be eligible for transfer for whatsoever reason during the temporary service of five years.
- c. That any person appointed against any available vacancy on the basis of being a resident of backward area or an area adjoining Line of Actual Control shall serve in such area for a period of not less than seven (7) years.
- d. That during the period of first five years, the appointee shall be entitled to the minimum scale of pay, along with the grade pay, applicable to the post against which she is appointed.
- e. That the appointee shall be entitled to annual increments, Dearness Allowance, House Rent Allowance and City Compensatory Allowance after successful completion of her five years of service on consolidated salary.
- f. That the appointee shall be entitled to the benefits under the Medical Attendance Rules and Leave Rules from the date of her appointment itself.
- g. That the seniority of the appointee shall reckon from the date of her appointment.
- h. That the period spent on probation/ consolidated salary shall also reckon for purposes of calculating the qualifying service of the appointee for pensioner and other benefits provided under SRO-202 of 2015 dated 30.06.2015.
- i. That in the matter of other conditions of service like age, qualification, discipline, conduct and other allied matters, a person appointed under these rules shall be governed by the recruitment rules of the service to which the post occupied by her belongs, besides, other rules, regulations and orders in vogue in the State Civil Services in general.
- j. That the appointee shall report within a period of 21 days from the date of issuance of this order, failing which her appointment will be treated as cancelled without any notice.
- k. That the salary of the above selected candidate shall not be drawn and disbursed unless and until her character/ antecedents are received from CID Headquarters and authentication of qualification/ other allied documents from the concerned issuing agency/ agencies.

Director, School Education, Jammu is directed to issue posting order in respect of the appointee, if joined, immediately to ZONE-III areas as notified in Para-5 of Government Order No.622-Edu of 2015 dated 22.12.2015 against available vacancy wherever the vacancy exist, and thereafter against the person who is presently posted in ZONE-III area beyond one year.

Director, School Education, Jammu shall, however, report if the appointee does not join after 21 days and will simultaneously issue public notice through print/ electronic media giving last and final opportunity to her, if not join, so that waiting list will be obtained from PSC and operated.





The appointment will also be subject to the outcome of the writ petition(s), if any, are pending in the Hon'ble Court of Law.
