- The appointment shall be made in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rule, 2020 notified vide S.O. 192 of 2020 dated 17.6.2020. IV.
- The cadres/Departments allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department. V.
- The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he/she shall also be
