3. Academic qualification Certificate.
4. Technical qualification certificate.
5. Character/antecedents verified from CID (J&K Police) required.
6. No Objection certificate from DIC/Employment Exchange; &
7. That these appointees have not been selected by any Recruiting Agency/or appointed in any other government department.
8. That the allowance other than what was admissible/due has not been drawn.
9. That these employees are working against clear vacancies/posts and have not been conveyed/recommended earlier by the Empowered Committee.

The orders of regularization shall be subject to the cancellation ab-initio, in case, at any stage it emerges that the certificates/documents furnished by the appointees are fake/fictitious.


