Subject:- Placement of PG Masters as I/C Lecturer in the discipline of Zoology.

Government Order No. 317 - Edu of 2017

Whereas, vide Government Order No.585-Edu of 2015 dated 30.10.2015, 40 PG Masters/ Teachers have been elevated as I/C Lecturers in the discipline of Zoology; and

Whereas, the elevation of below mentioned PG Masters to the post of I/C Lecturer (Zoology) had been kept withheld for the reason shown below against each:-

S.No.	Name	Reason
1.	Peer Manzoor Ahmad Qadri	Permission/ leave not taken
2.	Bashir Ahmad Malik,	Permission given by ZEO

Whereas, the case of aforesaid PG Masters was examined in the Department and it has been found that Mr.Bashir Ahmad Malik has not taken proper permission from the Competent Authority; and

Whereas, it has also been found that Peer Manzoor Ahmad Qadri has also not taken proper permission/ leave from Competent Authority and as such charge sheet was served upon him on 24.10.2016 through Director, School Education, Kashmir, for explaining his position within 21 days; and

Whereas, Peer Manzoor Qadri has furnished his reply to the charge-sheet served upon him which was further examined and Mr.Abid Hussain, KAS Joint Director (South) was appointed as Inquiry Officer vide Govt. Order No.30-Edu of 2017 dated 23.01.2017; and

Whereas, the Inquiry Officer has furnished his report along with specific recommendations in case of Peer Manzoor Qadri and the said report including the permission case of Mr.Bashir Ahmad Malik was examined in this Department; and

Whereas, after examining the matter in detail, it has been decided to take a lenient view in the mater and to release the elevation of above named PG Masters as I/C Lecturers (Zoology) after according post facto:-

- i. Permission for acquiring PG (Zoology) through regular mode in favour of Peer Manzoor Qadri from Kashmir University and in respect of Mr.Bashir Ahmad Malik from SJMU University, Kanpur.
- ii. Sanction to the grant of the Extraordinary Leave without pay in favour of Peer Manzoor Qadri and Mr.Bashir Ahmad Malik for the period they remained on the rolls of concerned Universities for acquiring PG Degree through regular mode.

Now, therefore, post facto permission for acquiring PG in Zoology through regular mode is accorded in favour of:-

1. Peer Manzoor Qadri from Kashmir University; and
2. Mr. Bashir Ahmad Malik from SJMU University, Kanpur.

Sanction is also accorded to the grant of extraordinary leave without pay in favour of above named two PG Masters for the period they have remained on the rolls of concerned Universities for acquiring PG Degree through regular mode.

Subsequently, in continuation to Government Order No.585-Edu of 2015 dated 30.10.2015, on the basis of seniority/ eligibility, the following two (2) PG Masters are hereby placed as I/C Lecturers in the discipline of **Zoology** in their own pay and grade with charge allowance as admissible under rules for a period of six months or till the posts are filled up on regular basis, whichever is earlier:-

The placements, however, shall not confer any superior claim or right upon them at the time of their confirmation and shall also be subject to the outcome of any court case that may be sub-judice in the court(s) of Law.

These I/C Lecturers shall report to Directorate of School Education Kashmir within 21 days from the date of issuance of this order. If any of the I/C Lecturer fails to join within the stipulated period of time, it shall be presumed that he has foregone the elevation and his placement as I/C Lecturer shall be withdrawn without any further notice.

The Directorate of School Education, Kashmir will allow them to join only after verifying the following:-

- (i) The bio-data/ service particulars of the promotees as mentioned against each.
- (ii) Any of the promotee who has already been working either as I/C Headmaster or I/C Lecturer in other discipline may not be allowed to join as I/C Lecturer (**Zoology**).
- (iii) That the in-service candidates who have acquired P.G Degree after availing the leave during his service and after obtaining the proper permission from the competent authority. In case during this verification, it is proved that they have failed to obtain the permission from competent authority or they had not availed proper leave/ deputation, their officiating placement shall be deemed to have been cancelled ab-initio without any further notice. The Director School Education shall immediate revert him back to his/ her original place of posting.

- (iv) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which acquired are valid, shall be determined by the concerned Directorate of School Education.
- (v) The officer(s) is not involved in any adverse case(s) (Vigilance/Crime etc) which fact shall be ascertained by the concerned Directorate of School Education Department.
- (vi) The placement is without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Vigilance or Crime Branch.
- (vii) That the in-service candidates who have done project during the Degree certificates have obtained leave, otherwise salary for the said period shall be deducted from the salary of concerned incumbent.

The Directorate of School Education, Kashmir shall ensure that all the above conditions are fulfilled by the official (Promotee) before he actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he will not be allowed to join and such cases shall be referred to the Administrative Department for further action.
