Subject: Placement of PG Master as I/C Lecturer in the discipline of Sanskrit.

On the basis of seniority/ eligibility, Smt.Renu Sharma, Master, HS Sari Palai whose service particulars are given herein below is hereby placed as I/C Lecturer in the discipline of **Sanskrit** in her own pay and grade with charge allowance as admissible under rules for a period of six months or till the posts are filled up on regular basis, whichever is earlier:-

The placement, however, shall not confer any superior claim or right upon him at the time of their confirmation and shall also be subject to the outcome of any court case that may be sub-judice in the court(s) of Law.

The I/C Lecturer shall report to DSE Jammu within 21 days from the date of issuance of this order. If the said I/C Lecturer fails to join within the stipulated period of time, it shall be presumed that she has foregone the elevation and his placement as I/C Lecturer shall be withdrawn without any further notice.

The case of PG Master, if she has done post-graduation through distance mode will be considered after verification of their documents and fulfillment of criteria laid down vide Government Order No. 252-HE of 2012 dated 30-12-2012.

The concerned Directorate of School Education will allow her to join only after verifying the following:-

- (i) The bio-data/ service particulars of the promotee as mentioned above.
- (ii) She may not be allowed to join as Lecturer (**Sanskrit**) if she is already been working either as I/C Headmaster or I/C Lecturer in other discipline
- (iii) That the in-service candidate has acquired P.G Degree after availing the leave during her service and after obtaining the proper permission from the competent authority, in case during this verification, it is proved that she has failed to obtain the permission from competent authority or she had not availed proper leave/ deputation, their officiating placement shall be deemed to has been cancelled ab-initio without any further notice. The Director School Education shall immediate revert her back to her original place of posting.
- (iv) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificate/ Institution from which acquired are valid, shall be determined by the concerned Directorate of School Education.
- (v) The officer is not involved in any adverse case(s) (Vigilance/Crime etc) which fact shall be ascertained by the concerned Directorate of School Education Department.

- (vi) The placement is without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Vigilance or Crime Branch.
- (vii) That the in-service candidate has done project during the Degree certificates have obtained leave, otherwise salary for the said period shall be deducted from the salary of concerned incumbent.

The concerned Directorate of School Education Department shall ensure that all the above conditions are fulfilled by the official (Promotee) before she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, she will not be allowed to join and case shall be referred to the Administrative Department for further action. If the official fulfill the above conditions and is allowed to join, be posted by the Directorates itself as per the transfer policy of the department.
