Subject:- Withdrawal of elevation of I/C Lecturers (non-joining) in the discipline of **Kashmiri**.

**Government Order No. 332 – Edu of 2016**

**D a t e d : 07 – 09 – 2016**

Whereas, **6 (six)** PG Masters/ Teachers were placed as I/C Lecturers in the discipline of **Kashmiri** vide Government Order **No.347-Edu of 2013 dated 21.03.2013** with the directions to report to the concerned Directorate within a period of 21 days from the date of issuance of the order for further adjustment; and

Whereas, after the expiry of the said period the DSE Kashmir/ Jammu intimated that out of **6 (six)** I/C Lecturers, **5 (five)** have not joined/ reported in the concerned Directorate on their elevation within the stipulated period of 21 days; and

Whereas, it was mentioned in the elevation order that any Lecturer who fails to join within 21 days from the date of issuance of the said order, it shall be presumed that he/ she has foregone the elevation and his/ her placement as I/C Lecturer shall be withdrawn without any further notice; and

Whereas, out of above **5 (five)** incumbents who have not joined in the concerned directorate(s), the following **2 (two)** have retired on superannuation from Government service;

Whereas, in view of the non-joining of incumbents on their elevation as I/C Lecturer (Kashmiri) within the stipulated period as intimated by the concerned Directorate, the elevation of I/C Lecturers in the discipline of **Kashmiri** issued vide Government Order **No.347-Edu of 2013 dated 21.03.2013** needs to be withdrawn with immediate effect; and

Whereas, the case was examined in this department and last/ final opportunity was afforded to other three (3) non-joining candidates through a notice issued by the Administrative Department on 07.04.2016 for joining as I/C Lecturer(s) in respective directorate(s) within a period of 15 days; and

Whereas, the Director, School Education Kashmir vide his letter No.DSEK/ PGMT-PF/ 241 dated 26.04.2016 has intimated that these three (3) candidates who have been given the last opportunity to join as I/C Lecturer (Kashmiri) have already been elevated as Headmasters and are still working as such from last 3 years;

Now, therefore, in view of position explained above, the elevation of following PG Masters as I/C Lecturers in the discipline of **Kashmiri** issued vide Government order No.347-Edu of 2013 dated 21.03.2013, is hereby withdrawn ab-initio:-
