**The regularization is further subject to following conditions:-**

- i) That Drawing & Disbursing Officers shall take an undertaking from the concerned Officer in the shape of an affidavit duly attested by a 1<sup>st</sup> Class Magistrate to the effect that if his/her service particulars/PG Certificate is found fake/forged/tempered or issued by un-recognized University or the course is proved as un-recognized at a later stage, he/she shall have no claim for the regularization and the regularization order issued in his/her be treated as cancelled ab-initio without further notice.

- ii) The Drawing & Disbursing Officers concerned will obtain LPC and other related details from the Drawing & Disbursing officer of their parent Institutions before fixing the pay of these Officers in the relevant pay scales as revised from time to time

The Drawing & Disbursing Officers shall be responsible for implementation/fulfillment of above conditions in letter and spirit.
