**Subject:- Placement of PG Masters as I/C Lecturer in the discipline of Mathematics.**

Whereas, Final Seniority List of PG Masters/Teachers in the discipline of Mathematics was issued vide Government Order No.463-Edu of 2017 dated 21.07.2017; and

Whereas, on the basis of Final Seniority List, placement orders in respect of 42 PG Masters as I/C Lecturer (Mathematics) were issued vide Government Order No.532-Edu of 2017 dated 11.08.2017 and 929-Edu of 2017 dated 15.11.2017 respectively; and

Whereas, among others, the placement of Mrs. Rama Kumari, Sty. No.129, PG Master, was kept withheld for the reasons that she has not taken leave from the Competent Authority for acquiring P.G Degree as detailed below:-

Whereas, the above Master has represented to this department alongwith relevant/deficient documents for issuance of placement order in her favour as I/C Lecturer on the plea that her Junior counterparts have been placed as I/C Lecturers; and

Whereas, the matter has been examined in the Administrative Department, and it has been decided to consider the placement of above mentioned Master as I/C Lecturer (Mathematics) and also to grant sanction for extra ordinary leave without pay of above PG Master for the period she has remained on leave while acquiring PG degree (Mathematics).

Now, therefore, sanction is accorded to the grant of extraordinary leave without pay in favour of Rama Kumari for the period she remained on leave for acquiring PG degree (Mathematics)

Consequent upon the above, on the basis of seniority/eligibility and as per particulars, sanction is hereby accorded to the placement of Ms. Rama Kumari, PG Master Sty.No.129, as I/C Lecturer in the discipline of Mathematics, in her own pay and grade with charge allowance as admissible under rules, for a period of six months or till his post is filled up on regular basis, whichever is earlier.

The above, placement, however, shall not confer any superior claim or right upon her at the time of her confirmation which shall be strictly, made as per Recruitment Rules. The above placement shall also be subject to the outcome of any court case that may be sub-judice in the Court (s) of law.

The I/C Lecturer shall report to Directorate of School Education, Jammu, within 21 days from the date of issuance of this order. If she fails to join within the stipulated period of time, it shall be presumed that she has foregone her elevation and her placement as I/C Lecturer shall be withdrawn without any further notice.

The Directorate of School Education, Jammu will allow her to join only after verifying the following:-

- (i) The bio-data/ service particulars of the promotee as mentioned above.
- (ii) If the promotee is working either as I/C Headmaster or I/C Lecturer in other discipline,s he may not be allowed to join as I/C Lecturer (Mathematics).
- (iii) That the mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which acquired are valid, shall be determined by the concerned Directorate of School Education.
- (iv) The promotee is not involved in any adverse case(s) (Vigilance/Crime etc) which fact shall be ascertained by the concerned Directorate of School Education Department.

The Directorate of School Education, Jammu, shall ensure that all the above conditions are fulfilled by the official (Promotee) before she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, she will not be allowed to join and her case shall be referred to the Administrative Department for further action.
