The appointee(s) shall report to Director School Education, Kashmir within a period of 21 days from the date of issuance of the appointment order. In case of failure of any of these appointee(s) to join within the stipulated period, the Director School Education Kashmir shall give last and final opportunity to such candidate(s) by issuing notice through print/electronic media and report to the Administrative Department for further action.

The appointee(s) shall be allowed to join only on production of the following certificates in original:-

- a) Academic qualification certificates.
- b) Matriculation/Date of Birth certificate.
- c) Health Certificate from the concerned Chief Medical Officer.
- d) Permanent Residence Certificate issued by competent authority.
- e) Reserved category certificate (if any).
- f) Certificate from the District Industries (DIC) and District Employment & counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee(s).
- g) Character/ antecedents certificates.

If on verification, the certificates produced by the appointee proved to be fake or forged, the appointment shall stand cancelled ab-initio.

The appointment of above candidate(s) as 10+2 lecturers in the School Education Department shall further be subject to the following conditions:-

- a. That the appointment of the selected candidate is strictly governed under SRO-202 of 2015 dated 30.06.2015.
- b. Each appointee shall submit an undertaking to the effect that in case adverse report about his character and antecedent is received from the Additional Director General of Police (CID), J&K to whom a reference shall be made by

the Director, School Education Department he shall have no right to claim his appointment as Lecturer and his appointment, as such, shall be deemed to have been cancelled ab-initio:

c. Verification/genuineness of the qualification, reserved category certificates etc.

from the concerned issuing authorities.

d. The salary of the appointee(s) shall not be drawn and disbursed to them unless the satisfactory reports in respect of (b) and (c) above are received in their favour.

e. That in the matter of other conditions of service like age, qualification, discipline, conduct and other allied matters, a person appointed under these rules shall be governed by the recruitment rules of the service to which the post occupied by him belongs, besides, other rules, regulations and orders in vogue in the State Civil Services in general.

The Director, School Education Kashmir, shall issue posting orders immediately in ZONE-III areas as notified vide Government Order No. 622-Edu of 2015 dated 22.12.2015 against available vacancies wherever these vacancies exist, or by shifting the persons presently posted in Zone-III areas beyond one year.

The appointments shall also be subject to the outcome of the writ petition(s), if any, pending before Hon'ble Court of Law.
