Subject: - Temporary placement of Post- Graduate Masters/Teachers as I/c Lecturers in the discipline of Information Technology/IP in School Education Department.

Government Order No. 364 -Edu of 2019
Dated: - 24 -10.2019

Pending clearance of the Departmental Promotion Committee and in continuation to Government Order No. 290-Edu of 2019 dated 04.09.2019, sanction is hereby accorded to the temporary placement of the following Masters/Teachers who are Post Graduate as I/c Lecturers in their own pay and Grade (OPG), in the discipline of **Information Technology/IP** with immediate effect for a period of six months or till post is filled up on regular basis by the Departmental Promotion Committee, whichever is earlier.

The placement shall not confer any superior claim or right for seeking regularization/confirmation, which shall be considered strictly following due procedure and clearance of DPC. All placements shall be subject to the outcome of any writ petition(s) that may be pending before the Court (s) of Law.

The above placements are subject to the following conditions:

- i. The Director School Education, Kashmir/Jammu shall verify the Post Graduate degrees obtained during service through distance mode in light of the Government Order No.940-Edu of 2017 dated 17.11.2017 and shall allow such Masters/ Teachers to join only when/ if the P.G degrees are found genuine.
- ii. The I/c Lecturer(s) shall report to the concerned Directorate of School Education within 21 days from the date of issuance of order. If any such lecturer(s) fail to join within the stipulated period of time, it shall be presumed that he/she has foregone his /her placement and his /her placement as I/c Lecturer shall deemed to have been withdrawn without any further notice.
- iii. **The Directorate of School Education, Kashmir/Jammu will allow them to join only after verifying the following:-**
 - a. The bio-data/service particulars of the I/c Lectures as mentioned above are correct.
 - b. A promotee already working either as I/c Headmaster or I/C lecturer in other discipline, shall not be allowed to join as I/c Lecturer in discipline of Information Technology/IP.
 - c. The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which he/she has acquired such degree, is valid. However, in light of the clarification issued by UGC vide letter No.1-15/2015(CPP-II) dated 17.08.2015, to UGC Regulation notification dated 25th Nov, 1985 the officials who had enrolled themselves in the first degree course prior to June 4, 1986 in (10+2+2) mode and who had successfully completed their first degree course, prior to June 4, 1986, irrespective of their duration shall be treated at par with those who have completed 03 years degree course and they are not required to undergo a further one year bridge course.
 - d. The officer is not involved in any criminal case (ACB/Crime etc) or proceedings which fact shall be ascertained by the concerned Directorate of School Education.
 - e. The concerned Directors after satisfying all conditions mentioned above shall post these I/c lecturers against the available vacancies preferably in Zone-III and far-flung areas.
 - f. The Directorate of School Education, Kashmir/Jammu shall ensure that all the above conditions are fulfilled by the official before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he/she will not be allowed to join and the Directorate shall refer the case to the Administrative Department for further course of action within 30 days, from issuance of order.

- iv. Any incumbent(s)/officials(s) aggrieved of this order, shall approach the Administrative Department through respective Directorates within 21 days from issue of this order, alongwith necessary documentary evidence in support of his/her claim. The respective Directors of School Education shall nominate one officer in their office for receiving grievance/representation, if any, in this regard.
