In addition to above, it is hereby ordered that:

- i. Sh. Bashir Ahmad Sheikh, Principal, HSS Boys, Manigam, shall hold the additional charge of ZEO Kangan, and Sh. Imtiyaz Ahmad, Principal, HSS Fatehgarh, Baramulla, shall hold the charge of ZEO Fatehgarh, Baramulla till the posts are filled up on regular basis.

- ii. Sh. Salah Mohammad, ZEPO, Kotranka, is assigned the responsibilities of ZEO Kotranka, purely on temporary basis, till the post of ZEO is filled up on regular basis.
- iii. Sh. Gulzar Ahmad Shah, ZEPO Gool, is assigned the responsibilities of ZEO Gool, purely on temporary basis, till the post of ZEO is filled up on regular basis.

The temporary arrangements ordered with reference to (ii) & (iii) above shall not confer any preferential right upon the officers to claim on regular basis as ZEO or equivalent.

Furthermore, Sh. Sakhi Mohammad, I/C Headmaster, GHS Marh Draj, is transferred and posted as ZEPO Kotranka *vice* Salah Mohammad. The case of non-joining of Sh. Sonam Tsomo, who was under transfer as ZEO Jourian, shall be decided separately.

Advance TE as admissible under rules is also sanctioned in favour of the officers in whose case change of station is involved.


