Government Order No.:- 368 - Edu of 2015 D a t e d:- 28 - 07-2015

Whereas, Sh. Bashir Ahmad Dar, Senior Lecturer, Political Science, awaiting orders of posting in the office of Director, School Education Jammu was transferred and posted to HSS Bani against an available vacancy vide Government Order No. 65-Edu of 2015 dated 13.02.2015; and

Whereas, Spouse of Sh. Bashir Ahmad Dar, represented this department to post her husband in Jammu city on the plea that their two minor children (Daughter & Son) are suffering from disability of hearing impairment (100% Deaf & Dumb); and

Whereas, the case was re-examined in the department and it was observed that there is no vacant post of Lecturer Political Science in Jammu city or surrounding area; and

Whereas, vide Government Order No. 244-Edu of 2015 dated 21.05.2015, Sh.Bashir Ahmad Dar was transferred to HSS R.S.Pura and in his place Sh. Rajesh Singh, who is Lecturer in HSS R S Pura and was posted in HSS Bani; and

Whereas, Principal, Boys HSS R.S.Pura vide his letter no. BHSS/RSP/199 dated 23.05.2015 reported that Sh.Rajesh Singh is actually Lecturer of History and cannot be replacement of Bashir Ahmad Dar and the name of Lecturer Political Science is Sh.Hans Raj; and

Whereas, Sh.Hans Raj is not having mature stay at Boys. HSS R.S.Pura and whereas, it has been reported that, Sh.Sanjeev Mangotra, Lecturer Political Science is having mature stay in Girls HSS R.S.Pura.

Now, therefore, in view of above position and in partial modification to Government Order No. 255-Edu of 2015 dated 21.05.2015, the following transfers and postings of Lecturers are hereby ordered with immediate effect:-
