In continuation to Government Order No. 344-Edu of 2015 dated 21-07-2015, it is hereby ordered that the appointment of Hon'ble Mr Justice (Retd) Hakim Imtiyaz Hussain, as Chairman of the committee for fixation of fee structure of the private educational institutions shall be governed by following terms and conditions:-

1	Pay	As admissible to a sitting Judge of Hon'ble High Court minus pension and commuted portion of pension, if any.
2	TA/DA/Medical Allowance/ other conditions of service	As Admissible to a sitting Judge of Hon'ble High court.
3	Conveyance	Staff car to be provided by the State Motor Garages with 200 liters of petrol per month or actual consumption (whichever is less)
4	Accommodation	Rent free accommodation or in lieu thereof House Rent Allowance as per entitlement of a sitting judge of Hon'ble High Court.
5	Telephone	Telephone at office and residence with a limit of 1000 calls per month for the latter.
6	Sumptuary Allowance	As admissible to a sitting Judge of Hon'ble High Court.
