Re-instatement/Cancellation of transfer of Mr. Bilawar Ahmad Zargar, Lecturer (Botany) to Leh District.

Whereas, among others, Sh. Bilawar Ahmad Zargar, Lecturer (Botany) was transferred and posted to GHSS Leh vide Govt. Order No. 228-Edu of 2016 dated 22.06.2016; and

Whereas, Mr. Bilawar Ahmad Zargar did not join at GHSS Leh; and

Whereas, Mr. Bilawar Ahmad Zargar was placed under suspension vide Govt. Order No. 378-Edu of 2016 dated 30.09.2016 as he had not complied with the instructions laid down under the aforesaid transfer order issued by this Department and displayed indiscipline and non-seriouness towards his legitimate duties by not joining at his respective place of posting; and

Whereas, Mr. Bilawar Ahmad Zargar, submitted a representation to this department requesting for his re-instatement and cancellation of his transfer to Leh on the plea that his elder brother died due to heart attack and he was in deep shock and that his wife is suffering from severe ailments that required constant care; and

Whereas, the matter has been examined in this department and it has been decided to take a lenient view in the matter in view of the ailment of his wife.

Now, therefore, sanction is hereby accorded to the re-instatement of Mr. Bilawar Ahmad Zargar ordered vide Government Order No. 378-Edu of 2016 dated 30.09.2016, with immediate effect.

Sanction is also accorded to the cancellation to transfer of Mr. Bilawar Ahmad Zargar to Leh ordered vide Gvernment Order No.228-Edu of 2016 dated 22.06.2016. He shall report to Director School Education, Kashmir, for further posting.
