Subject:- Transfers/postings of Lecturers from/to the districts of Leh and Kargil and suspension thereof.

Government Order No: 378 –Edu of 2016

D a t e d : 30 .09. 2016

Whereas, various Lecturers of different streams had been transferred to Leh & Kargil districts *vide* Government Order Nos: 140-Edu of 2016 & 228-Edu of 2016, dated 12.04.2016 & 22.06.2016 respectively.

Whereas, it was categorically mentioned in the aforesaid Government Orders that the concerned HOD(s)/Principal(s) shall relieve all the transferees to Leh & Kargil within a period of 03 days, failing which the transferees shall be deemed to have been relieved from their respective places of postings and join their new places of postings within the stipulated period. It was also mentioned that in case transferees do not comply with the Government Orders and fail to join their new places of postings, action as warranted under rules shall be taken against them without any further notice, which may include withdrawal of elevation.

Whereas, to harmoniously blend transfers and inculcate discipline in the department, especially in view of the Government Order issued *vide* No: 327-Edu of 2015 dated 10.07.2015, the new incumbents are supposed to join at their respective places of postings forthwith, if there is no pre-existing medical condition.

Whereas, some of the transferees approached the Administrative Department for modification of their transfer(s) for one or the other reason.

Whereas, representations of officials mentioned in Annexure 'A' were examined and after due consideration, were found to be devoid of any merit.

Whereas, it has been established that these officials, indicated in **Annexure A** to this Order, have not complied with the instructions laid down under the transfer order/directions issued by this department and have displayed indiscipline and non-seriousness towards their legitimate duties by not joining at their respective places of postings.

Now, therefore, in view of above, the Lecturers mentioned in **Annexure A** to this Order are hereby placed under suspension with immediate effect, with the

direction to report to the concerned Directorates. It is further ordered that the concerned Directorates shall furnish all relevant particulars / documents of the suspended Lecturers to the Administrative Department to initiate departmental proceedings / serve charge-sheets upon them.

This Order, however, shall not be operative in respect of those officials where Hon'ble High Court has issued any interim direction staying the operation of the transfer orders and in such cases the department shall take further action as per the orders / directions of the HHC.
