Whereas, vide Government Order No: 69-Edu of 2015 dated:18-2-2015, among others, Sh. Kuldeep Kumar Jalali, Desh Kumar Hangloo, Vinay Kumar Hangloo, Roshan Lal Koul, Ramesh Kumar Raina, Santosh Kumar, Vinod Kumar Koul, Ravinder Kumar Bhat, Devinder Handoo, Satish Kumar Pandita, Hira Lal Pandita and Vinod Kumar Jad, all I/C Principals were transferred and posted against the available vacancies in the Higher Secondary Schools; and

Whereas, Sh. Kuldeep Kumar Jalali and others challenged the said Government Order No: 69-Edu of 2015 dated: 18.2.2015 before the Hon'ble High Court through the above titled writ petition seeking quashment of said impugned order; and

Whereas, the Hon'ble High Court vide interim order dated: 26.02.2015, has passed the following directions:-

*"Meanwhile, subject to objections from the other side and till next date before the Bench, operation of impugned order No: 69-Edu of 2015 dated: 18.02.2015 qua the petitioners, shall stay".*

Whereas, objections stand filed in rebuttal to the claim of petitioners and matter is pending adjudication before the Hon'ble High Court; and

Whereas, the schools where the petitioners were posted are without Principals which is likely to adversely affect the academic performance of these schools; and

Whereas, the matter has been reconsidered in the Department and it has been decided to post available substitutes on these posts so that the schools do not suffer any further ;and

Whereas it has been taken note of that the petitioners have remained attached for varying durations without being assigned any substantive work;and.

Whereas, the petitioners as per their writ petition have *inter-alia* have expressed their willingness to serve in Srinagar;and

Whereas, in view of the willingness expressed by the petitioners, the posting of petitioners is modified as under:-
