Whereas, among others, Mr.Saber Hussain (ALC), Teacher, MS Kandi Gulhota was also placed as I/C Lecturer in the discipline of Botany under ALC Category (serial No.24) vide Government Order No.08-Edu of 2013 dated 02.01.2013 on the basis of updated seniority list issued vide Circular No.08-Edu of 2012 dated 28.06.2012; and

Whereas, in light of said placement order, the promotee was required to report to concerned Directorate within a period of 21 days from the date of issuance of the placement order; and

Whereas, after a long period, the DSE Jammu vide his letter dated 28.12.2015 has forwarded the representation of one Mr.Saber Hussain, Master who has requested therein for accepting of his joining report as Lecturer (Botany) and stated that being posted in the far flung (winter zone) area, Mr.Saber Hussain has not received any information of his promotion and during submission of documents for verification of seniority he came to know that he has already been elevated as I/C Lecturer in Botany vide Govt. Order No.08-Edu of 2013 dated 02.01.2013; and

Whereas, the case was examined in the Administrative Department, and it has been found that it is untenable that the official was not aware of his promotion as I/C Lecturer (Botany) for so long i.e about 3 years; and

Now, therefore, having failed to join in the respective Directorate of School Education within the stipulated time period, the placement of Mr.Saber Hussain (ALC), Teacher as I/C Lecturer issued vide Government Order No.08-Edu of 2013 dated 02.01.2013 is hereby withdrawn/ cancelled ab-initio.
