Regularization of I/C Lecturers as Lecturers in the discipline of

Mathematics.

Whereas, vide Government Order No.236-Edu of 2013 dated 07.03.2013, 158 I/C Lecturers were regularized as Lecturer in the discipline of Mathematics; and

Whereas, after issuance of the aforesaid regularization order, Shri Brij Paul Singh, Master represented before this department for his regularization as Lecturer (Mathematics) on the plea that he was placed as I/C Lecturer on 06.01.2004 and has not been regularized as Lecturer (Mathematics); and

Whereas, the case was examined in this department and, among other cases, his case for regularization as Lecturer (Mathematics) w.e.f 08.07.2005 (i.e the date his junior counterparts have been regularized as such) was placed before the Designated Committee in its meeting held on 28.01.2016; and

Whereas, after detailed deliberations, the said Committee has approved the regularization of Sh.Brij Paul Singh as Lecturer (Mathematics) w.e.f 08.07.2005 and decided to regularize him against the vacancy of 08.07.2005 in the relevant category by pushing down the last candidate strictly as per seniority for regularization w.ef. 16.11.2005 who was earlier considered for regularization w.e.f 08.07.2005 so on so forth. The Committee also decided that the last candidate regularized w.e.f 16.11.2005 be pushed down for effecting regularization w.e.f 13.05.2008 i. e the date from which twenty (20) vacancies in the relevant discipline are available with the Department.

Now, therefore, in pursuance to the Cabinet Decision referred to above and o the recommendations of the Designated Committee and in partial modification to Government Order No. No.236-Edu of 2013, dated 07.03.2013, sanction is hereby ordered to the:-

a. Regularization of Shri Brij Paul Singh, PG Master (working as I/C Lecturer in the discipline of Mathematics) whose service particulars are given below, as Lecturer (Mathematics) in the relevant pay scale as revised from time-to-time from the date as indicated below:-

b. Regularization of Sh.Om Dutt Sharma w.e.f 16.11.2005 instead of 08.07.2005 who has already been regularized w.e.f 08.07.2005 at serial No.108, vide Government Order No.236-Edu of 2013 dated 07.03.2013

The Director, School Education, Jammu shall ensure that the regularization of the above incumbents shall be effected only after fulfilling the following conditions:-

- that the mode of acquiring degree (i.e. 10+2+2 (Bridge Course)/10+2+3) as well as the genuineness of P.G. certificate/ Institutions from which degree has been acquired is valid and validity of category certificate, if any, shall be determined by the concerned Drawing & Disbursing Officers before fixing his/her pay and if on verification, the certificate(s) produced by the Lecturer are proved fake or forged, the regularization shall be treated cancelled ab-initio.
- (ii) the Drawing & Disbursing Officer shall take an undertaking in a shape of an affidavit duly attested by the 1<sup>st</sup> Class Magistrate from the concerned Lecturers to the effect that if his service particulars/ PG Certificate is proved to fake/ forged/ tempered or issued by un-recognized University or the course itself is proved as un-recognized, he shall have no claim for the regularization and the regularization order issued in his favour be treated as cancelled ab-initio without further notice.
- (iii) that the concerned have acquired P.G. Degree after availing leave during his studies / obtained proper permission, as the case may be.
- (iv) the Drawing & Disbursing Officer concerned before fixing the pay of the Lecturer in the relevant pay scales as revised from time to time will obtain LPC and other related details (I, ii & iii above) from the Drawing & Disbursing Officers of their parent Institutions.
- (v) the regularization is without prejudice to the outcome of any writ petition pending in any competent court (s) of law or any case pending in Vigilance or Crime Branch.

The Drawing & Disbursing Officer shall be responsible for implementation/fulfillment of above conditions in letter and spirit.
