In terms of the decisions taken in the meeting held on 8.7.2015 for implementation of the directions passed by the Hon'ble High Court in the case titled 'Faisal Ahmed Khan V/S state and Ors', it has been decided to collect data of degrees/certificate of ReTs/RReTs obtained through Study center/Distance mode in the office of Chief Education Officer concerned, **w.e.f 11.8.2015**. The Chief Education Officers shall establish sufficient number of cells, depending upon the number of ReTs/RReTs working in the district. The number and constitution of cells, each comprising of two Gazetted Officers, shall be approved by the Director concerned. The entire exercise shall be completed within a period of 07 days from the date of commencement.

A complete set of self attested documents (with name and phone No.) shall be retained for verification of genuineness, validity, etc of the degrees.

The Director, School Education concerned shall personally monitor the progress and submit daily status report to the Administrative Department.
