Subject:-Placement of PG Masters as I/C Lecturers in the discipline of Bio-Chemistry.

On the basis of seniority/ eligibility, the following two (2) PG Masters are hereby placed as I/C Lecturers in the discipline of Bio-Chemistry in their own pay and grade with charge allowance as admissible under rules for a period of six months or till the posts are filled up on regular basis, whichever is earlier:-

These placements, however, shall not confer any superior claim or right upon them at the time of their confirmation and shall also be subject to the outcome of any court case that may be sub-judice in the court(s) of Law.

The I/C Lecturers shall report to concerned Directorate of respective divisions within 21 days from the date of issuance of this order. If any, I/C Lecturer(s) who fails to join within the stipulated period of time, it shall be presumed that he/she has foregone elevation and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The concerned Directorate of School Education will allow them to join only after verifying the following:-

- The bio-data/ service particulars of the promotees as mentioned against each. (i)
- Any of the promotee who has already been working either as I/C Headmaster or I/C (ii) Lecturer in other discipline may not be allowed to join as I/C Lecturer (Bio-Chemistry).
- the claim of the superior shall be considered, if any, by demoting the junior one. (iii)
- That the in-service candidates who have acquired PG Degree after availing the leave (iv) during his/her service and after obtaining the proper permission from the competent authority. In case during this verification, it is proved that they have failed to obtain the permission from competent authority or they had not availed proper leave/ deputation, their officiating placement shall be deemed to have been cancelled ab-initio without any further notice. The Director School Education shall immediate revert him back to his/ her original place of posting.
- The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which acquired are valid, shall be determined by the concerned Directorate of School Education.



(vii) The placement is without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Vigilance or Crime Branch.

(viii) That the in-service candidates who have done project during the Degree certificates have obtained leave, otherwise salary for the said period shall be deducted from the salary of concerned incumbent.

The concerned Directorate of School Education Department shall ensure that all the above conditions are fulfilled by an Official (Promotee) before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by an Official, he/she will not be allowed to joins and such cases shall be referred to Administrative Department for further action.
