Subject: Wrong opening of question papers in Board examinations.  
Re-instatement thereof.

WHEREAS, on the basis of report received from JKBOSE dated 03.03.2017, pending enquiry into the matter of opening of question papers of subject, which were not scheduled to be held on 02.03.2017 and 03.03.2017 of Class-10<sup>th</sup> (Annual) Regular, 2017. The following officers/ officials of School Education, Department, Jammu, were placed under suspension *vide* Government Order No. 85-Edu of 2017, dated 04.03.2017. It was further ordered that Mr. Charandeep Singh, KAS, Joint Director, Jammu/Kathua/Samba will conduct the preliminary enquiry into matter with direction to furnish his report within a period of seven days:



*WHEREAS*, the Director, School Education, Jammu has served the necessary Article of Charges along with Statement of Imputations to the above five (05) delinquent employees for furnishing their replies with documentary evidence / written statement *vide* his office memorandums dated 19.09.2017 and accordingly submitted their replies alongwith his recommendation /comments *vide* his letter dated 08.11.2017. Besides the DSEJ also intimated that prolong suspension of these employees is not justified and we are giving idle wages/subsistence allowance without any assignment and also recommended for their re-instatement.

*WHEREAS*, the case was further examined in the School Education Department, with reference to the replies of the charge-sheet of the above five (05) delinquent employees of School Education Department, Jammu and it has been decided to accept the replies to the charge-sheets of these officers / officials. Besides the DSEJ has intimated that the prolong suspension of these employees is not justified and we are giving idle wages / subsistence allowance without any assignment and also recommended for their re-instatement and re-instate them into Government services by treating their period of suspension as on leave whatever kind due including extra ordinary leave or leave without pay by also awarding further punishment by debarring them from all future invigilation/assignments duties of JKBOSE; and



NOW, therefore, sanction is hereby accorded to the re-instatement of the following officers/ officials into Government services by treating their period of suspension as on leave whatever kind due including extra ordinary leave or leave without pay by also awarding further punishment by debarring them from all future invigilation / assignments duties of JKBOSE:
