In terms of Jammu and Kashmir (Compassionate Appointment) Rules, 1994, sanction is hereby accorded to the temporary appointment of Mr. Vishvesh Bali, S/o Lokesh Bali and Late Smt. Summan Chhibber (Ex-Master), R/o H.No. 116 Shiv Vihar Janipur Colony, Jammu, as **Teacher**, in the Pay Scale of Rs. 5200-20200 with Grade Pay of Rs.2800/-, in District Cadre Jammu of the School Education Department.

The appointee shall report to the Chief Education Officer, **Jammu**, within a period of 21 days from the date of issuance of this order and he shall be allowed to join only after production of the following certificates/documents in original:-

1. Academic qualification certificates.
2. Age and Health Certificate
3. Permanent Resident Certificate.
4. No Demand Certificate from DIC & Employment Department.
5. Category Certificate, if any

If on verification, the certificates produced by the appointee are proved fake, the appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory report about the verification of his character and antecedents is received from Inspector General of Police, CID, to whom a reference shall be made by the Chief Education Officer, **Jammu**.
