Subject:- Placement of PG Masters as I/C Lecturers in the discipline of Sociology.

On the basis of seniority issued vide Government Order No. 830-Edu of 2017 dated 23.10.2017, and eligibility required for the placement as I/C Lecturers, the following eleven (11) PG Masters are hereby placed as I/C Lecturers in the discipline of **Sociology**, in their own pay and grade, with charge allowance as admissible under rules, for a period of six months or till the posts are filled up on regular basis, whichever is earlier:-

These placements, however, shall not confer any superior claim or right upon them at the time of their confirmation and shall also be subject to the outcome of any court case that may be sub-judice in the court(s) of Law.

The I/C Lecturers shall report to concerned Directorate of respective divisions within 21 days from the date of issuance of this order. If any I/C Lecturer(s) who fails to join within the stipulated period of time, it shall be presumed that he/she has foregone the elevation and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The case of those PG Masters/ Teachers who have done post-graduation through 'distance mode' will be considered after verification of their documents and fulfillment of criteria laid down vide Government Order No. 252-HE of 2012 dated 30-12-2012, read with Government Order No: 940-Edu of 2017 dated 17.11.2017.

The concerned Directorate of School Education will allow them to join only after verifying the following:-

- (i) The bio-data/ service particulars of the promotees as mentioned against each.
- (ii) Any of the promotee who has already been working either as I/C Headmaster or I/C Lecturer in other discipline may not be allowed to join as I/C Lecturer (**Sociology**).
- (iii) The In-service candidates who have acquired P.G Degree are required to avail the leave during his/her service and after obtaining the proper permission from the competent authority. In case during this verification, it is proved that they have failed to obtain the permission from Competent Authority or they had not availed proper leave/ deputation, their officiating placement shall be deemed to have been cancelled ab-initio without any further notice. The Director School Education shall immediately revert him back to his/ her original place of posting.
- (iv) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which he or she has such degree acquired are valid, shall be determined by the concerned Directorate of School Education.
- (v) The officer(s) is not involved in any adverse case(s) (Vigilance/Crime etc) which fact shall be ascertained by the concerned Directorate of School Education Department.
- (vi) The placement is without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Vigilance or Crime Branch.
- (vii) That the in-service candidates who have done project during the Degree certificates have obtained leave, otherwise salary for the said period shall be deducted from the salary of concerned incumbent.

The concerned Directorate of School Education Department shall ensure that all the above conditions are fulfilled by the official (Promotee) before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he/she will not be allowed to join and such cases shall be referred to the Administrative Department for further action. Those officials, who fulfill the conditions and are allowed to join, be posted by the respective Directorates as per the transfer policy of the department.


