Sanction is hereby accorded to the temporary appointment of Mtr. Shahmal Begum W/o Late Fayaz Ahmad (Ex-Teacher) R/o Bhimdasa, Tehsil and District Ramban, as Class –IV, in the Pay Band of Rs.4440-7440 with Grade Pay of Rs. 1300/- in the School Education Department, in District Cadre Ramban, in relaxation of prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, Ramban within a period of 21 days from the date of issuance of this order and she shall be allowed to join only after production of the following certificates/documents in original:

- 1. Age and Academic qualification certificate.
- 2. Permanent Resident Certificate.
- 3. Character and antecedent's Certificate.
- 4. No Demand certificate from DIC & Employment Exchange.
- 5. Category Certificate, if any

However, if on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of her character and antecedents is received from Inspector General of Police, CID to whom a reference shall be made by the Chief Education Officer, Ramban.
