However, if on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be on probation for a period of two years. The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of her character and antecedents is received from Inspector General of Police, CID to whom a reference shall be made by the Chief Education Officer, Rajouril
