Sanction is hereby accorded to the temporary appointment of Mtr. Shahzada, W/o Late Ghulam Qadir Magray (Ex-Chowkidar), R/o New Colony, Batamaloo, as Class-IV, in the Pay Band of Rs.4440-7440 with Grade Pay of Rs.1300 /- in School Education Department in District cadre **Srinagar**, in relaxation of the prescribed age/qualification in terms of Rule-7, under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, **Srinagar** within a period of 21 days from the date of issuance of this order and shall be allowed to join only after production of the following certificates/documents in original:-

- 1. Age and academic qualification certificates.
- 2. Permanent Resident Certificate.
- 3. Character and antecedent's certificates.
- 4. No Demand Certificate from DIC & Employment Exchange.
- 5. Category certificate, if any

However, if on verification, the certificates produced by the appointee are proved fake, the appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of her character and antecedents is received from Inspector General of Police, CID, to whom a reference shall be made by the Chief Education Officer, **Srinagar**.
