They are directed to report to concerned Chief Education Officer, Leh/kargil. The concerned HOD/Principal shall relieve them one week before opening of school after winter vacation, failing which the transferee shall be deemed to have been relieved from their respective place of posting and join their new place of posting within the stipulated time. Otherwise action under rules shall be taken against those who fail to join their new place of postings without any further notice. The present DDO will not draw their salary beyond the period of relieving. Any deviation from the same would be treated as dereliction of duty on part of DDO concerned making him liable to

disciplinary action. Besides, they are allowed to travel by air for joining at their new place of posting.
