Subject: - Winter vacation in Kashmir Division/Winter Zone of Jammu Division and arrangements for winter schooling.

Government Order No. 485 - Edu of 2016
Dated: 13 -12-2016

It is hereby ordered that the Government/Private Recognized Schools of Kashmir Division and Winter Zone of Jammu Division shall observe winter vacation as per the following schedule:-

- I. The last working day of classes upto 8th standard shall be 15.12.2016 and the winter vacation shall be observed w.e.f. 17.12.2016 to 28.02.2017.
- II. The last working day of classes 9th standard onwards shall be 24.12.2016 and the winter vacation shall be observed w.e.f. 26.12.2016 to 28.02.2017.

Further, in terms of the departmental policy to provide optional winter schooling to the students to compensate the loss suffered during the current year, the Director School Education Kashmir shall take following steps:

- a) Notify Schools where classes will be held during winter vacation for class 8th to 12th and for those students who have taken the 12th exams.
- b) Notify Schools for holding of Super-50 coaching.
- c) Select teachers to be deployed for conduct of classes/coaching in these Schools, who shall be provided incentive in terms of Rule 27 of the Jammu and Kashmir Civil Services (Leave) Rules, 1979.
- d) Make all infrastructural arrangements for the smooth conduct of classes/coaching.

Similar arrangements for winter schooling/coaching shall be made by DSE, Jammu.

It is further ordered that officials associated with the conduct of practical examinations shall avail winter vacations only after conclusion of the practical examinations. Further, officials required to undergo training, as per the schedule already notified by the Chief Education Officers, shall compulsorily attend the training programme. The teaching faculty shall report for duties on 27th February, 2017 to supervise arrangements for re-opening of Schools.
