Subject:-Placement of PG Masters as I/C Lecturer in the discipline of Zoology.

Government Order No. 491- Edu of 2017

Whereas, vide Government Order No.585-Edu of 2015 dated 30.10.2015, **40** PG Masters/ Teachers have been elevated as I/C Lecturers in the discipline of Zoology; and

Whereas, among others, the elevation of Mr.Ghulam Qadir, Master as I/C Lecturer (Zoology) was kept withheld for the reason that he has not taken permission/leave from the competent authority; and

Whereas, the Mr.Ghulam Qadir, Master has represented this department for release of his elevation as I/C Lecturer (Zoology) which was examined and found that he has not taken proper permission/ leave from the Competent Authority; and

Whereas, after examining the case in detail, it has been decided to take a lenient view in the mater and to release the elevation of Mr. Ghulam Qadir, PG Master as I/C Lecturers (Zoology) after according post facto permission in his favour for acquiring PG (Zoology) through regular mode from Kashmir University. It has also been decided to sanction Extraordinary Leave (EOL) without pay in his favour for the period he remained on the rolls of University for acquiring PG Degree through regular mode.

Now, therefore, sanction is hereby accorded to the grant of post facto permission in favour of Mr. Ghulam Qadir, PG Master for acquiring PG in Zoology through regular mode from Kashmir University. Sanction is also accorded to the grant of extraordinary leave (EOL) without pay in his favour for the period he remained on the rolls of Kashmir University for acquiring PG Degree through regular mode.

Subsequently, in continuation to Government Order No.585-Edu of 2015 dated 30.10.2015 and on the basis of seniority/ eligibility, Mr. Ghulam Qadir, Master presently posted at Lalpora whose service particulars are given hereunder is hereby placed as I/C Lecturer in the discipline of **Zoology** in his own pay and grade with benefit of charge allowance, as admissible under rules, for a period of six months or till the post is filled up on regular basis, whichever is earlier:-

The placement, however, shall not confer any superior claim or right upon him at the time of his confirmation and shall also be subject to the outcome of any court case that may be sub-judice in the court(s) of Law.

The promotee Lecturer shall report to Directorate of School Education Kashmir within 21 days from the date of issuance of this order. If he fails to join within the stipulated period of time, it shall be presumed that he has foregone his elevation and his placement as I/C Lecturer shall be withdrawn without any further notice.

The Directorate of School Education, Kashmir will allow him to join only after verifying the following:-

(i) The bio-data/ service particulars of the promotee as mentioned above.

(ii) If the promotee is working either as I/C Headmaster or I/C Lecturer in other discipline, he may not be allowed to join as I/C Lecturer (**Zoology**).

(iii) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which acquired are valid, shall be determined by the concerned Directorate of School Education.

(iv) The promotee is not involved in any adverse case(s) (Vigilance/Crime etc) which fact shall be ascertained by the concerned Directorate of School Education Department.

(v) The placement is without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Vigilance or Crime Branch.

(vi) That the in-service candidate, if had done project during the Degree certificate have obtained leave, otherwise salary for the said period shall be deducted from the salary of concerned incumbent.

The Directorate of School Education, Kashmir shall ensure that all the above conditions are fulfilled by the official (Promotee) before he actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he will not be allowed to join and his case shall be referred to the Administrative Department for further action.
