Whereas, the matter has been examined with reference to the rules governing the subject. It has been observed that having resigned from Jammu and Kashmir School Education (Gazetted) Service, on 27.08.2016, for undertaking employment in Higher Education Department, Mtr. Aliya Muzaffar has ceased to be the member of the Jammu and Kashmir School Education (Gazetted) Service, in terms of Article 37 of the J&K Civil Service Regulations, 1956;

Whereas, it has accordingly been decided by the Competent Authority to accept the resignation of Mtr. Aliya Muzaffar, w.e.f 27.08.2016, on her own request, and order deemed termination of her lien from the Jammu and Kashmir School Education (Gazetted) Service.
