Now, therefore, the seniority of Smt. Sushma Sharma, Master GHS Gurha Slathia is fixed at seniroty No.199-A and Smt. Anupam Gupta, Master, GMS Mehmoodpora Zone Bishnah at seniority No. 199-B in the updated/final seniority list of PG Masters/Teachers in the discipline of Political Science issued vide Government Order No. 469-Edu of 2017 dated 24.07.2017.

Consequent upon above and in continuation to Government Order No. 545-Edu of 2015, dated 16.08.2017, Smt. Sushma Sharma, Master, presently posted at GHS Gurha Slathia, and Smt. Anupam Gupta, presently posted at GMS Mehmoodpora Zone Bishnah is hereby placed as I/C Lecturer (Political Science) in his own pay and grade with benefit of charge allowance, as admissible under rules, for a period of six months or till the post is filled up on regular basis, whichever is earlier.

The placement, however, shall not confer any superior claim or right upon him at the time of their confirmation and shall also be subject to the outcome of any court case that may be sub-judice in the court(s) of Law. The placement shall also be subject to any case pending in Vigilance Organization/ Crime Branch.

The promotee Lecturer shall report to Directorate of School Education Jammu within 21 days from the date of issuance of this order. If any I/C Lecturer fails to join within the stipulated period of time, it shall be presumed that he/she has foregone the elevation and his/her, placement as I/C Lecturer shall be withdrawn without any further notice.

The Directorate of School Education, Jammu will allow them to join only after verifying the following:-

- (i) The bio-data/ service particulars of the promotee as mentioned above.
- (ii) If the promotee is working either as I/C Headmaster or I/C Lecturer in other discipline, he may not be allowed to join as I/C Lecturer (Political Science).
- (iii) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which acquired are valid, shall be determined by the concerned Directorate of School Education.
- (iv) The promotee is not involved in any adverse case(s) (Vigilance/Crime etc) which fact shall be ascertained by the concerned Directorate of School Education Department.

The Directorate of School Education, Jammu shall ensure that all the above conditions are fulfilled by the official (Promotee) before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, they will not be allowed to join and his case shall be referred to the Administrative Department for further action.
