Subject: Placement of Headmasters and equivalent as I/C Zonal Education Officers and equivalent of School Education Department.

**Government Order No : 541 - Edu of 2015
D a t e d : 20 -10 -2015**

On the basis of seniority of Headmasters (issued vide Govt. Order No.334-Edu of 2013 dated 19.03.2013) and eligibility, the Headmasters and equivalent as indicated in Annexure-'A' to this Government Order are hereby placed as I/C Zonal Education Officers and equivalent in their own pay and grade with charge allowance as admissible under rules for a period of six months or till the posts are filled up on regular basis whichever is earlier.

These placements, however, shall not confer any superior claim or right upon them at the time of confirmation of I/C Zonal Education Officers which shall be ordered strictly in terms of recruitment rules. These placement shall also be the subject to the outcome of the writ petition(s), pending, if any, before any competent court(s) of law. However, the claim of superior shall be considered, if any, by demoting the junior one.

Consequent upon above, the posting of these officials is ordered as indicated against each in Annexure-'B'.

The officers placed as I/C ZEO and equivalent shall join at their new place of posting within 21 days from the date of issuance of this order. In case, they fail to join within the stipulated period of time, it shall be presumed that he/she has forgone his/her placement to the post of I/C ZEO and equivalent and next eligible officer shall be considered for promotion accordingly, without any further notice.


