The above placements shall be purely on temporary basis and shall not confer any preferential right upon these officers for their regular promotion against these posts at the time of regularization, which shall be made strictly on the basis of seniority and in terms of extant recruitment rules. The above placements shall also be subject to the outcome of writ petition (s), if any, pending in competent Court of Law.

The officers elevated to the post of ZEOs and equivalent in Incharge capacity, shall report at their places of postings within 21 days from the date of issuance of this order. In case, they failed to join within the stipulated period of time, it shall be presumed that he/she has forgone his/her elevation to the post of Incharge ZEO and equivalent and next eligible officer in the relevant category shall be considered for elevation accordingly without any further notice. The placement is further subject to the receipt of Vigilance Clearance from the concerned Department to which the reference has been made. In the event of receipt of any adverse report, the placement of such officers shall be reversed without any notice.
