The appointee shall report to the Chief Education Officer, Rajouri within a period of 21 days from the date of issuance of this order and she shall be allowed to join only after production of the following certificates/documents in original:-

- 3. Character and antecedent's Certificates
- No Demand Certificate from DIC and Employment Exchange 4.
- 5. Category Certificate, if any

However, if on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be deemed to have been cancelled Ab-Initio.

The appointee shall be on probation for a period of two years. The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of her character and antecedents is received from Inspector General of Police, CID to whom a reference shall be made by the Chief Education Officer, Rajouri.
