The Committees shall inspect all the ETT Institutes including institutes belonging to the petitioners and all those which have obtained directions from the Hon'ble High Court at Kashmir/Jammu for grant of NOCs in their favour.

The Committees shall submit its inspection report to the Administrative Department for functioning and grant of NOCs in favour of ETT institutions in accordance with the rules and orders passed by the Department from time to time subject to the clearance from Crime Branch.


