Sanction is hereby accorded to the temporary appointment of Ms. Bushra Abdullah, D/o Mohd Abdullah Para (Sister of Late Neyaz Ahmad Para), (Ex-Teacher), R/o Naira, District Pulwama, as Teacher, in the Pay Scale of Rs. 5200 - 20200, with Grade Pay of Rs.2800/- in the School Education Department, in District Cadre Pulwama, in terms of Sub rule 2 of Rule 3 of SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, Pulwama, within a period of 21 days from the date of issuance of this order and she shall be allowed to join only after production of the following certificates/documents in original:-

- 1. Age and academic qualification certificates.
- 2. Permanent Resident Certificate.
- 3. Character and antecedents certificate.
- 4. No Demand Certificate from DIC & Employment Exchange.
- 5. Category Certificate, if any

However, if on verification, the certificates produced by the appointee are proved fake, the appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of her character and antecedents is received from Inspector General of Police, CID, to whom a reference shall be made by the Chief Education Officer, Pulwama.
