9. That these employees are working against clear vacancies/posts and have not been conveyed/recommended earlier by the Empowered Committee.

The orders of regularization shall be subject to the cancellation ab-intio in case at any stage it emerges that the certificates/documents furnished by the appointees are fake/fictitious.


