Whereas, Jammu and Kashmir Public Service Commission, vide their communication No. PSC/DR/Lect.English (10+2)/2016, dated 01.04.2017, forwarded select list of candidates for the post of Lecturer 10+2 in the discipline of English of School Education Department; and

Whereas, on the basis of recommendations of Public Service Commission, 52 candidates were appointment as Lecturers (10+2) in the discipline of English in the School Education Department vide Government Order No. 183-Edu of 2017 dated 21.04.2017; and

Whereas, the appointees were directed to join/report to the concerned Directorate of School Education of respective Divisions within a period of 21 days from the date of issuance of order, failing which appointment orders will be cancelled without any notice; and

Whereas, Ms. Rashmeet Kour D/o Omkar Singh R/o H.No. 74, Block-B, Gandhi Nagar Jammu figuring at S.No. 19 under OM Category and Mr. Jamphel Sheyan S/o Tsering Palge R/o Village Testa Block Cha PO Padum Zanskar Kargil, figuring at S.No. 2 under ST Category in the appointment order issued vide Government Order No. 183-Edu of 2017, dated 21.04.2017, have failed to join in the Directorate of School Education, Jammu/Kashmir within the stipulated time period; and

Whereas, Directorate of School Education, Jammu/Kashmir have given final opportunity to respective candidates to join their duties within a week's time positively by issuance of notice through print media in daily newspapers viz. "Daily Excelsior" and "Greater Kashmir" on 16.07.2017 and 13.04.2017 respectively, however, the candidates again failed to join in their respective Directorates.

Now, therefore, the appointment of above candidates, namely, Ms. Rashmeet Kour D/o Omkar Singh R/o H.No. 74, Block-B, Gandhi Nagar Jammu figuring at S.No. 19 under OM Category and Mr. Jamphel Sheyan S/o Tsering Palge R/o Village Testa Block Cha PO Padum Zanskar Kargil, figuring at S.No. 2 under ST Category, as Lecturer 10+2 in the discipline of English, issued vide Government Order No. 183-Edu of 2017 dated 21.04.2017 is hereby cancelled *ab-initio*.

Consequent upon above, sanction is hereby accorded to the appointment of following candidates as Lecturer 10+2 in the discipline of English in the School Education Department, in the pay scale of 9300-34800 plus Grade pay of


