Whereas, Jammu and Kashmir Public Service Commission, vide their communication No. PSC/DR/Lect.Urdu (10+2)/2016, dated 01.04.2017, forwarded select list of candidates for the post of Lecturer 10+2 in the discipline of Urdu of School Education Department; and

Whereas, on the basis of recommendations of Public Service Commission, 58 candidates were appointment as Lecturers 10+2 in the discipline of English in the School Education Department vide Government Order No. 182-Edu of 2017 dated 21.04.2017; and

Whereas, the appointees were directed to join/report to the concerned Directorate of School Education of respective Divisions within a period of 21 days from the date of issuance of order, failing which appointment orders will be cancelled without any notice; and

Whereas, Mr. Mohd. Sharif S/o Mohd Ayub R/o Village Jagti P/O Nagrota, Jammu figuring at S.No. 9 under OM Category in the appointment order issued vide Government Order No. 182-Edu of 2017, dated 21.04.2017, has failed to join in the Directorate of School Education, Jammu within the stipulated time period; and

Whereas, Directorate of School Education, Jammu has given final opportunity to the above candidate to join within a week's time positively by issuance of notice through print media in daily newspapers viz. "Daily Excelsior" on 16.07.2017, however, he again failed to join in the Directorate of School Education, Jammu.

Consequent upon above, sanction is hereby accorded to the appointment of Mr. Rayeis Ahmad Ganie S/o Mohammad Ashraf Ganie R/o Khore Sherabad Pattan as Lecturer 10+2 in the discipline of Urdu in the School Education Department, in the pay scale of Rs. 9300-34800 plus Grade pay of Rs. 5400/-, strictly in terms of SRO-202 of 2015 dated 30.06.2015, by operating waiting list of respective

category as the candidate is figuring at S.No. 1 of the waiting list under Open Merit category.
