**Subject:-** Placement of PG Masters as I/C Lecturers in the discipline of Mathematics.

Whereas, final seniority list of PG Masters/Teachers in the discipline of Mathematics was issued vide Government Order No. 463-Edu of 2017 dated 21.07.2017; and

Whereas, on the basis of above seniority list, elevation order of 38 PG Masters as I/C Lecturer (Mathematics) was ordered vide Government Order No. 532-Edu of 2017 dated 11.08.2017; and

Whereas, among other, the elevation of following PG Masters was kept withheld for the reasons that they have not taken prior permission/leave from the Competent Authority for accruing P.G Degree as detailed below:-

Whereas, above Masters have represented to this department alongwith relevant/deficients documents for release of their elevation as I/C Lecturers on the plea that their juniors have been elevated as I/C Lecturers; and

Whereas, the matter has been examined in the Administrative Department and it has been decided to consider the elevations of above Masters as I/C Lecturers after according post facto permission for acquiring PG (Mathematics) in favour of S.No. 1 & 2 and also grant sanction for extra ordinary leave without pay in favour of all the above PG Masters for the period they have been remained on leave for acquiring PG degree (Mathematics).

Now, therefore, post facto sanction is hereby accorded to the grant of permission to acquire PG Degree in Mathematics in favour Mr. Mohammad Shafi Rather and Mr. Nazir Ahmad Bhat (S.No. 1&2 above) and also sanction is accorded to the grant extraordinary leave without pay in favour of all the Masters (From S.No. 1 to 7)

mentioned above for the period they have remained on leave for acquiring PG Degree (Mathematics) from University of Kashmir/Jammu.

Consequent upon the above and on the basis of seniority/eligibility/service particulars, sanction is hereby accorded to the placement of following Masters as I/C Lecturer in the discipline of **Mathematics**, in their own pay and grade with charge allowance as admissible under rules, for a period of six months or till these posts are filled up on regular basis, whichever is earlier:-

The above placement, however, shall not confer any superior claim or right upon them at the time of confirmation which shall be considered strictly as per Recruitment Rules. The above placement, shall also be subject to the outcome of any court case that may be sub-judice in the Court (s) of law.

The I/C Lecturers shall report to the concerned Directorate of School within 21 days from the date of issuance of this order. If he/she fails to join within the stipulated period of time, it shall be presumed that he/she has foregone his/her elevation and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The Directorate of School Education, Kashmir/Jammu will allow them to join only after verifying the following:-

- (i) The bio-data/service particulars of the promote as mentioned above are correct.
- (ii) If the promotes have already been working either as I/C Headmaster or I/C Lecturer in any other discipline, he may not be allowed to join as I/C Lecturer (Mathematics) and the matter may be brought inot the notice of Administrative Department.
- (iii) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions

- (iii) from which he/she has acquired such degree are valid, shall be determined by the concerned Directorate of School Education.
- (iv) The officer is not involved in any adverse case (s) (Vigilance/Crime etc.) shall be ascertained by the concerned Directorate of School Education.
- (v) The placement is without prejudice to the outcome of any writ petition pending in any competent court (s) of law or any case pending in Vigilance or Crime Branch.

The Directorate of School Education, Kashmir/Jammu shall ensure that all the above conditions are fulfilled by the official (promotee) before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he/she will not be allowed to join and the Directorate shall refer the case to the Administrative Department for further course of action.


