List of Lecturers/ Masters/ Teachers/ Non-teaching staff/ Class-IV found guilty by UFM (Unfair Means) Committee of JKBOSE - reinstatement thereof.

Government Order No:68/-Edu of 2018 Dated: 14.05.2018

WHEREAS, Chairman JK BOSE, vide communication No: F(PSS/CU)17, dated 14.08.2017, has forwarded two lists comprising 46 Lecturers/ Masters/ Teachers/ Non-teaching staff and Class IV employees of the School Education Department who were assigned invigilation duties as Superintendents, Deputy Superintendents and Assistant Superintendents in various Board examinations during the session 2016-17 across the state and were found abetting in use of unfair means, thus violating the sanctity of the aforesaid examinations; and

WHEREAS, vide Government Order No. 757-Edu of 2017, dated 11.10.2017, as many as 46 Lecturers/ Masters/ Teachers/ Non-teaching staff and Class IV employees of the School Education Department were placed under suspension with immediate effect. However, it was also ordered that during their period of suspension, they shall report at their respective places of postings where they are presently posted; and

WHEREAS, JKBOSE vide its letter dated 25.10.2017, has informed that among the 46 suspended officers/ officials of the School Education Department, as many as 9 officers/ officials of Kashmir Division have been exonerated by the Review/ Appellate Committee of JK BOSE from the charge of resorting to unfair means, and, accordingly vide Government Order No. 917-Edu of 2017, dated 27.10.2017, these nine officers/ officials of Kashmir Division were reinstated into Government service by treating their period of suspension as on duty. However, it was further ordered that the above officers / officials shall remain careful in future as any misdemeanour on their part shall attract action under extant rules; and

WHEREAS, vide Government Order No. 138-Edu of 2018, dated 08.02.2018, Government Order No. 204-Edu of 2018, dated 21.02.2018 and Government Order No. 530-Edu of 2018, dated 10.04.2018, sanction was accorded to the re-instatement of 33 officers / officials of the School Education Department into Government service with immediate effect, by treating their period of suspension as on leave whatever kind due, including extraordinary and leave without pay, after accepting their replies to the charge-sheets served upon them. It was further ordered that the above officers/ officials shall be debarred from future invigilation assignments of JK BOSE. They shall also be warned to remain careful in future in dissemination of their duties; and

WHEREAS, Secretary JK BOSE vide communication dated 31.03.2017, has also forwarded the case of Mr. Mohammad Shafi Bhat, Teacher, Middle School, Khird-Chadoora, District Budgam, who is presently under suspension in the unfair means case in

terms of Government Order No. 757-Edu of 2017, dated 11.10.2017 while working as Assistant Superintendent in Centre No. 2140/SSE/ Annual/ Private-2016. The Secretary JK BOSE has intimated that pursuant upon the meeting of the Review Committee (UFM) held on 29.03.2018 in JKBOSE to review the case of the aforesaid official, it was unanimously resolved that a lenient view may be taken in his case; and

WHEREAS, the case has been examined in the Administrative Department on the analogy of other similarly-circumstanced cases which stand already decided. It has been decided to also reinstate Mr. Mohammad Shafi Bhat, Teacher, Middle School, Khird-Chadoora, District Budgam, into Government service with immediate effect by treating his period of suspension as on leave whatever kind due to him, including extra-ordinary leave and leave without pay. It has been further decided that the above official shall be debarred from future invigilation duties of JKBOSE and he shall also be warned to remain careful in future; and

NOW, therefore, in view of the recommendations of JK BOSE, sanction is hereby accorded to the re-instatement of Mr. Mohammad Shafi Bhat, Teacher, Middle School, Khird-Chadoora, District Budgam, who was placed under suspension byide Government Order No: 757-Edu of 2017, dated 11.10.2017, into Government service with immediate effect by treating his period of suspension as on leave whatever kind due to him, including extra-ordinary leave and leave without pay.

It is further ordered that the above official shall be debarred from future invigilation assignments of JK BOSE and he shall also be warned to remain careful in future.
