Assigning of look-after charge of the posts of Chief Education Officers

& equivalent.

Government Order No. 72 - Edu of 2019 Dated: 21 . 02 . 2019

Whereas, the School Education Department filled up the posts of Chief Education Officer & equivalent falling under OM category, on officiating basis vide

Government Order No. 37-Edu of 2019, dated 01.02.2019; and

Whereas, the posts of Chief Education Officers & equivalent falling under various reserved categories in terms of reservation rules, could not be filled up on officiating capacity basis in view of the advisory from Law Department/ General Administration Department vide O.M. No. LD(Opn)2015/101-CS, dated 22.01.2016 read with GAD's O.M. No. GAD/MTG/RB-IV/04/2016, dated 04.03.2016 on the strength of Apex Court directions; and

Whereas, these unfilled posts are of administrative nature and the Department

cannot afford to keep them vacant, causing practical problems; and

Whereas, it has been decided to fill these posts by assigning the charge for look-after the administrative responsibilities of the post, without Drawing & Disbursing powers, to the officers from the feeding service in order of seniority and eligibility;

Now, therefore, in view of the administrative exigencies, it is hereby ordered that the following officers shall look-after the posts of Chief Education Officers & equivalent indicated against each till the posts are filled up on officiating or regular basis through DPC, whichever is earlier: -

However, the officers assigned look-after charge shall not be entitled to charge allowances. The arrangement is purely temporary and shall not confer any right upon the officers to claim seniority/placement/promotion/regularization, which shall be done as per rules.

The above arrangement shall be without prejudice to the outcome of writ petitions, if any, pending consideration before the courts of competent jurisdiction.
